Important Dates



October 12 **VOTER REGISTRATION DEADLINES**
Pre-registration by mail ends at 5 pm. Online pre-registration ends at 11.59 p.m.

Oct 13 - Nov 1 Register in person at Minneapolis Elections & Voter Services (with proof of residence) or register when you vote by mail. If you are not registered and apply to vote by mail, you will automatically be mailed a voter registration application to complete and mail back with your filled-in ballot.

November 2 Register at your polling place (**with proof of residence**)

Sep 17 - Nov 1 **VOTING DEADLINES**
Early voting in person or by mail

November 2 **Election Day 7 a.m. - 8 p.m.**
Vote in person at your assigned polling place. Find your polling place at: pollfinder.sos.state.mn.us

OR

Return your mail (absentee) ballot in person by 3 p.m. to Minneapolis Elections & Voter Services, 980 East Hennepin Ave, Minneapolis, 55414. **Mail (absentee) ballots cannot be dropped off at polling places.**

ACCEPTED PROOF OF RESIDENCE:

- **Photo ID with current address** (driver's license, learner's permit, state ID card, tribal ID, passport, U.S. Military or veteran ID, MN university or technical college ID, MN high school ID)
- **Photo ID plus a document with current address** (bill, account or start-of-service statement due or dated within 30 days of the election, or residential lease or rental agreement)
- **A registered voter in your precinct who will vouch for your residency.** A registered voter can vouch for up to eight voters. You cannot vouch for others if someone vouched for you.

*Note: Voting by mail takes time. Apply for your mail (absentee) ballot as soon as possible to allow for mailing delays. Refer to **How to Vote by Mail** in this guide.*

To Be Able to Vote in Minnesota You Must Be:



- 1 A U.S. citizen
- 2 At least 18 years old on Election Day
- 3 A resident of Minnesota for 20 days
- 4 Finished with all parts of any felony sentence
- 5 You can vote while under guardianship unless a judge specifically has revoked your right to vote.
- 6 You cannot vote if a court has ruled that you are legally incompetent.

How to Vote in Person

Early voting (Begins September 17 and ends November 1 at 5 p.m.)

You may vote early in person at Minneapolis Elections & Voter Services, 980 East Hennepin Avenue, Minneapolis 55414. **You cannot vote at the Hennepin County Government Center for this Minneapolis election.**

For early voting hours at the above address, go to vote.minneapolismn.gov/voters/vote-early-in-person.

On Election Day (November 2) 7 a.m. – 8 p.m.

To find your polling place go to mnvotes.org or call 311. You can also call 651-215-1440, or Safe at Home at 651-201-1399.

You will need to bring proof of residence if:

- You are not registered
- You have moved since you last voted
- You have changed your name since the last election
- You have not voted in the last four years

How to Vote by Mail (Absentee)

Apply for a Mail (Absentee) Ballot

You can apply for a mail (absentee) ballot anytime, but the City of Minneapolis recommends applying **at least 14 days before the election**. If you are not registered when you request your mail (absentee) ballot, you will automatically receive a voter registration form along with your ballot. Both forms can be completed and returned together.

You can print an application at vote.minneapolismn.gov or call 311 to request a paper copy to be mailed to you (allow extra time for possible mailing delays).

ASSEMBLE YOUR BALLOT MATERIALS

- You will need a witness when you sign your mail (absentee) ballot.
- Your witness must be a registered Minnesota voter or a notary.
- Once you complete your ballot, place it in the tan envelope.
- Place the tan envelope into the white signature envelope. **You must sign the white signature envelope. A witness must also sign the witness signature box.**



Return Your Ballot

MAIL YOUR BALLOT

Place the white signature envelope into the white mailing envelope. This envelope does not need a stamp. **You are encouraged to mail your ballot as soon as you fill it out, but the City of Minneapolis recommends returning it at least 7 days before the election.** To be counted, mail (absentee) ballots must be received in the mail by 8 p.m. on Election Day, November 2.



OR

RETURN YOUR MAIL (ABSENTEE) BALLOT IN PERSON

to Minneapolis Elections & Voter Services, 980 East Hennepin Ave, Minneapolis, 55414. **Do not return your ballot to Hennepin County Government Center.**



- You can deliver your ballot Monday-Friday, 8 a.m.-4:30 p.m. between September 17 and November 1.
- On Election Day, ballots may be delivered to the Minneapolis Elections & Voter Services office no later than 3 p.m.
- Mail (absentee) ballots cannot be dropped off at a polling place.
- If you have questions, call 311.

If You Need Help With Your Ballot

Beginning September 17, you can ask almost anyone you choose who is 18 or older, and is not a candidate, an employer, or a member of your union, to help you vote, drop off, or mail your ballot. This person can help drop off or mail ballots for no more than three people. **If you drop off a ballot for someone else, you must show identification with your name and signature.**

Between October 26 and November 2, in a few cases (such as living in a nursing home) an “agent” can pick up your blank ballot and bring it to you to complete, and then mail it or drop it off for you. The agent can pick up your ballot starting 7 days before the election until 2pm on November 2 and return it no later than 3pm on November 2 to Minneapolis Elections & Voter Services, 980 Hennepin Ave E, **not to your polling place.**

Curbside voting: If you cannot enter the polling place on election day, you can register and vote from the curb.

Be An Informed Voter – Know The Rules

Ranked Choice Voting

Ranked choice voting information comes from vote.minneapolismn.gov.

Ranked choice voting (RCV) is a voting method where you vote for up to three candidates in the order of your preference. This allows you to ‘rank’ your vote - first choice, second choice, and third choice. This method can allow your vote to count toward another candidate if your favorite candidate loses. For example, if your first-choice candidate doesn’t win, your vote is transferred to your second choice.

HOW TO MARK YOUR RCV BALLOT

- 1** Choose your top candidate. This is your first-choice candidate and will be the vote that is considered first.
- 2** If you have a second choice (**optional**), you may select another candidate. This choice must be different from your first-choice candidate.
- 3** If you have a third choice (**optional**), you may choose another candidate. This choice must be different from your first and second choices.

HOW YOUR VOTE IS COUNTED

All first-choice votes are counted. If no candidate has the required number of votes to win -- more than 50% -- the candidate with the fewest votes is eliminated. This process continues until a candidate has enough votes to win. Election officials only use your second or third choice if your first choice has already been eliminated.

Minneapolis Mayor

JOB DESCRIPTION

The Mayor's role is like that of a chief executive officer of the City. **Length of term:** Four years
Salary: \$136,101

OFFICIAL DUTIES

- Ensures that laws and ordinances are enforced within the City, and that city officers do their jobs
- Serves as executive officer of the City of Minneapolis and is leader for the City of Minneapolis at the State Legislature
- Presides over the City Council Executive Committee and Board of Estimate and Taxation meetings
- Nominates department head candidates such as the Police Chief, Fire Chief and Budget Director
- Appoints representatives to agencies and commissions
- Proposes policy direction in the annual State of the City address
- Approves or vetoes all City Council and Park Board actions (Vetoes can be overturned by two-thirds vote of the City Council or Park Board.)
- Does not determine property taxes and city budget

JOB DESCRIPTION

The City Council is Minneapolis' main governing body, responsible for approving new and future city developments. The Council governs through its legislative, administrative, and financial powers. The Council uses a committee system in which each committee handles a specific area of city policy. There are 13 City Council members, each representing a ward. See map on page 10 to find your ward.

Length of term: Four years
Salary: \$106,101

OFFICIAL DUTIES

- Establishes policies for city departments
- Exercises budgetary and policy control over city departments
- Sets property taxes to raise money for the city budget (within the limits set by the Board of Estimate and Taxation)
- Licenses city businesses
- Enforces rules that regulate public and private activities, including uses of property, prevention of crime, and ensuring public health and welfare

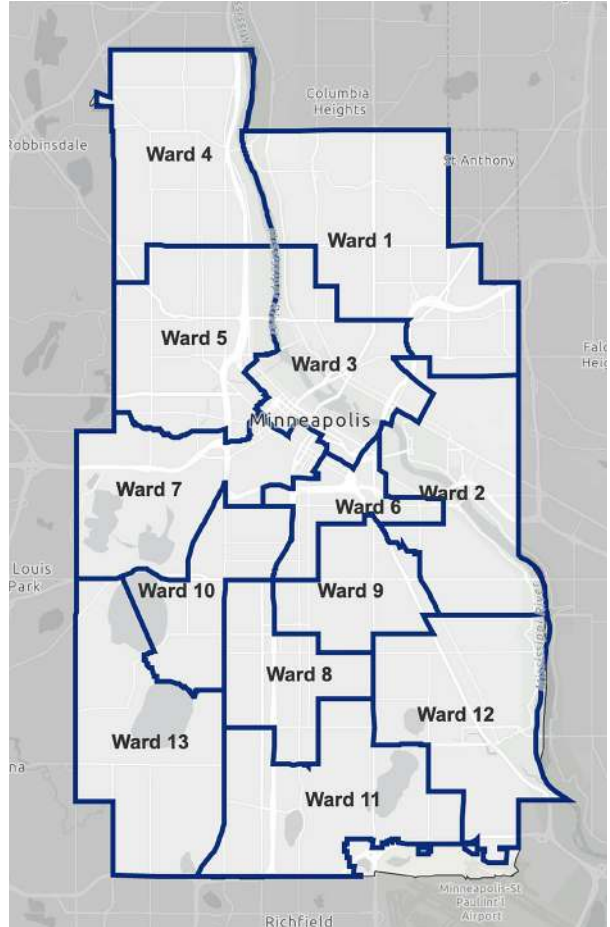

Salary: \$12,438
(President: \$13,853)

OFFICIAL DUTIES

- Develops park policies
- Enacts ordinances governing the use of neighborhood and regional parks,

- parkways, beaches and lakes, and special use facilities such as pools, ice arenas and golf courses
- Appoints the Superintendent

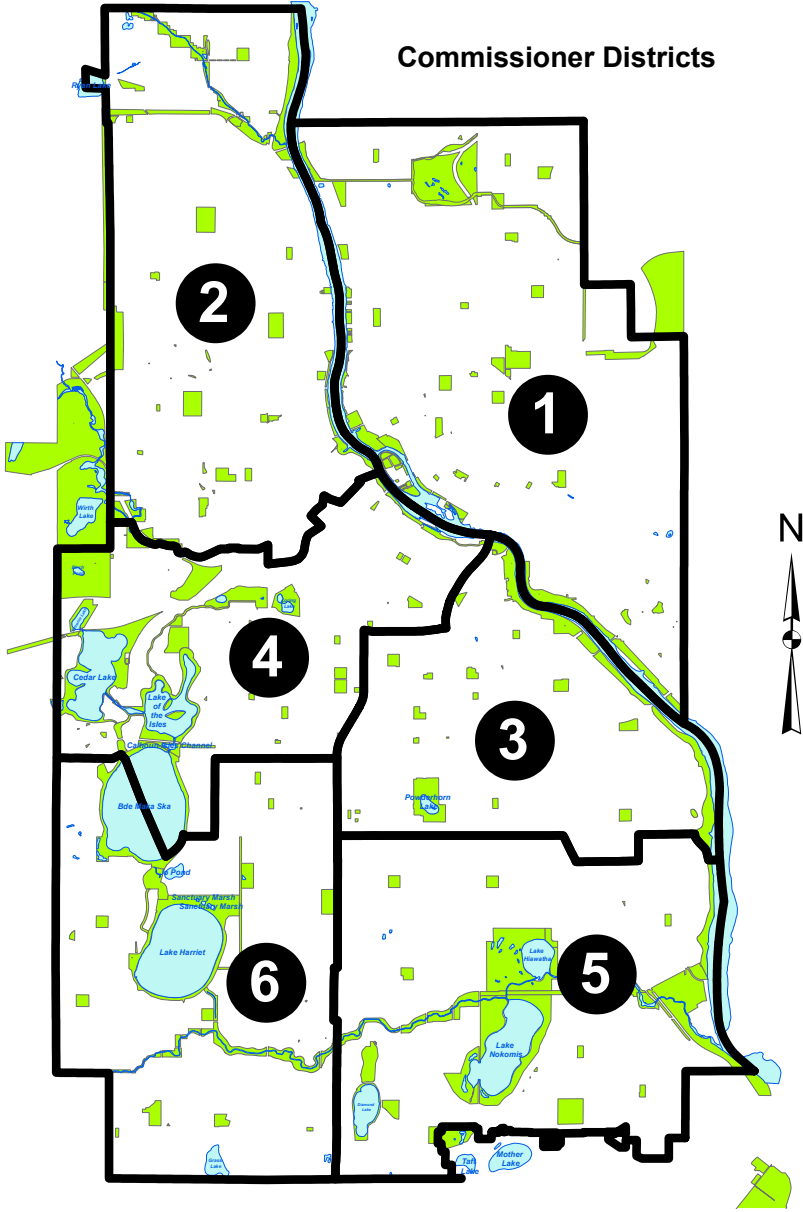

Minneapolis Board of Estimate and Taxation (BET) ★

JOB DESCRIPTION

Oversees the city's budget operations and audits the city's finances. The board is made up of six members. Two members are elected by the voters. The unelected members are the following:

1. Mayor
2. City Council President
3. City Council member who chairs the Council budget committee
4. Park and Recreation Board Commissioner

Length of term: Four years for the elected members

Salary: The two elected members receive a per diem

OFFICIAL DUTIES

- Coordinates various taxing and borrowing powers for the City
- Holds public hearings to gain citizen input regarding maximum tax levies for certain City tax funds, and sets maximum tax levies for the following funds: the City Council, the Park and Recreation Board, and the Board of Estimate and Taxation
- Issues General Obligation Bonds of the City in support of the Capital Program

Be an Informed Voter – Know the City’s Charter (Our Constitution)

The Minneapolis Charter Commission – How it works

The Charter Commission oversees the Charter, the City’s “Constitution,” which specifies how Minneapolis operates and what it may do as a government entity. The Commission’s fifteen members are appointed by the Chief Judge of Hennepin County to four-year terms.

The first Charter, adopted in 1920, has been amended several times. In 2013 a major revision called the “plain language charter” was approved by voters and adopted.

THE CHARTER

- Defines how the City government is structured and what it can do
- Sets up the process for how official actions and decisions are made
- Manages redistricting for Minneapolis (occurs in 2021 and every 10 years, following the census)

Two paths to amend the City Charter:

- 1 By ballot question – An amendment made into law by a majority of the voters
- 2 By ordinance – An amendment made into law by ordinance, which requires all members of the City Council to vote “yes” and the Mayor to approve it

Charter Amendments on the Ballot:

City Question 1

GOVERNMENT STRUCTURE: EXECUTIVE MAYOR – LEGISLATIVE COUNCIL

Shall the Minneapolis City Charter be amended to adopt a change in its form of government to an Executive Mayor-Legislative Council structure to shift certain powers to the Mayor, consolidating administrative authority over all operating departments under the Mayor, and eliminating the Executive Committee?

City Question 2

DEPARTMENT OF PUBLIC SAFETY

Shall the Minneapolis City Charter be amended to remove the Police Department and replace it with a Department of Public Safety that employs a comprehensive public health approach to the delivery of functions by the Department of Public Safety, with those specific functions to be determined by the Mayor and City Council by ordinance; which will not be subject to exclusive mayoral power over its establishment, maintenance, and command; and which could include licensed peace officers (police officers), if necessary, to fulfill its responsibilities for public safety, with the general nature of the amendments being briefly indicated in the explanatory note below, which is made a part of this ballot?

Explanatory Note:

This amendment would create a Department of Public Safety combining public safety functions through a comprehensive public health approach to be determined by the Mayor and Council. The department would be led by a Commissioner nominated by the Mayor and appointed by the Council. The Police Department, and its chief, would be removed from the City Charter. The Public Safety Department could include police officers, but the minimum funding requirement would be eliminated.

City Question 3

AUTHORIZING CITY COUNCIL TO ENACT RENT CONTROL ORDINANCE

Shall the Minneapolis City Charter be amended to authorize the City Council to regulate rents on private residential property in the City of Minneapolis, with the general nature of the amendments being indicated in the explanatory note below, which is made a part of this ballot?

Explanatory Note:

This amendment would:

1. Authorize the City Council to regulate rents on private residential property in the City of Minneapolis by ordinance.
2. Provide that an ordinance regulating rents on private residential property could be enacted in two different and independent ways:
 - a. The City Council may enact the ordinance.
 - b. The City Council may refer the ordinance as a ballot question to be decided by the voters for approval at an election. If more than half of the votes cast on the ballot question are in favor of its adoption, the ordinance would take effect 30 days after the election, or at such other time as provided in the ordinance.
